EIGHT AMENDMENT OF REGULATION OF THE MINISTER OF FINANCE
NUMBER 110/PMK.010/2006 CONCERNING GOODS CLASSIFICATION
SYSTEM AND IMPORT CUSTOMS LEVIED ON IMPORTED GOODS

MINISTER OF FINANCE,

- Considering
- a. That based on Regulation of the Minister of Finance Number 110/PMK.010/2006 concerning Goods Classification System and Import Customs Levied on Imported Goods as several times amended most recently by Regulation of the Minister of Finance Number 80/PMK.011/2011, goods classification system and import customs levied on imported goods is stipulated;
 - b. That in order to improve domestic filming industry development and to facilitate the import tax levy, it is necessary to conduct amendment on goods classification system and import customs levied on imported goods in the form of particular cinematography film product;
 - c. That based on consideration as referred in letter a and letter b, as well as in order to conduct provision of Article 12 item (3) Act Number 10 Year 1995 concerning Customs as several times amended by Act Number 17 Year 2006, it is necessary to stipulate the Regulation of the Minister of Finance concerning the Eight Amendment on Regulation of the Minister of Finance Number 110/PMK.010/2006 concerning Goods Classification System Determination and Import Customs Levied on Imported Goods;

4. Regulation of the Minister of Finance Number 110/PMK.010/2006 concerning Goods Classification System and Import Customs Levied on Imported Goods as several times amended most recently by Regulation of the Minister of Finance Number 80/PMK.011/2011;

DECIDES:

To stipulate : REGULATION OF THE MINISTER OF FINANCE CONCERNING THE EIGHT AMENDMENTS ON REGULATION OF THE MINISTER OF FINANCE NUMBER 110/PMK.010/2006 CONCERNING GOODS CLASSIFICATION SYSTEM DETERMINATION AND IMPORT CUSTOMS LEVIED ON IMPORTED GOODS.

Article I

To amend goods classification system and import customs levied on particular cinematography film product as referred in Appendix II of Regulation of the Minister of Finance Number 110/PMK.010/2006 concerning Goods Classification System Determination and Import Customs Levied on Imported Goods as several times amended most recently by Regulation of the Minister of Finance Number 80/PMK.011/2011 that referred in Chart I of Appendix of this Regulation of the Minister of Finance, thus it becomes good classification system and import customs levied on particular cinematography film product as referred in Chart II of Appendix of this Regulation of the Minister of Finance as an integrated part of this Regulation of the Minister of Finance.

Article II

This Regulation of the Minister of Finance shall come into force on its promulgation date.
