REGULATION OF THE MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA NUMBER 160/PMK.07/2011

CONCERNING

IMPLEMENTATION OF FUND TRANSFER OF SPECIFIC ALLOCATION OF FISCAL YEAR 2011

BY THE GRACE OF GOD ALMIGHTY

THE MINISTER OF FINANCE,

Considering

- : a. that in terms of implementation and responsibility of fund transfer to regions which has been stipulated in Regulation of the Minister of Finance Number 126/PMK.07/2010 concerning the Implementation and Responsibility of Fund Transfer to Region;
 - b. that in Regulation of the Minister of Finance Number 126/PMK.07/2010, it has set that Report of Absorption Realization of Specific Fund Allocation Stage I or Stage II is submitted after the use of Specific Fund Allocation has reached 90% (ninety percent) of the receipt of Specific Fund Allocation to the previous stage;
 - c. that in accordance with Conclusion of Work Meeting of Budget Agency of the Regional House of People's Representatives of the Republic of Indonesia with the Government in Terms of Discussion Level I/Discussion of Bills on the Amendment of Act Number 10 Year 2010 concerning State Budget of Fiscal Year 2011 dated July 5, 2011 to July 22, 2011, the implementation of transmission of Specific Fund Allocation of Fiscal Year 2011 which requires absorption minimum 90% (ninety percent) of the Specific Fund Allocation of Fiscal Year 2011 which has been transmitted in the previous stage does not count the absorption of Specific Educational Fund Allocation of Fiscal Year 2011 in regions;
 - d. that based on consideration as referred to in item a, item b, and item c, there is a need to stipulate Regulation of the Minister of Finance concerning the Implementation of Transmission of Specific Fund Allocation of Fiscal Year 2011;

DECIDES:

To stipulate

: REGULATION OF THE MINISTER OF FINANCE CONCERNING IMPLEMENTATION OF FUND TRANSFER OF SPECIFIC ALLOCATION OF FISCAL YEAR 2011.

Article 1

- (1) Transmission of Specific Fund Allocation (DAK) of Fiscal Year 2011 Stage II and Stage III is made after region submits Report of Absorption Realization of DAK of Fiscal Year 2011 in which the use has reached 90% (ninety percent) of DAK receipt of Fiscal Year 2011 to the previous stage.
- (2) Report of Absorption Realization of DAK of Fiscal Year 2011 as referred to in paragraph (1) does not count the portion and absorption of DAK of Education of Fiscal Year 2011 for region which has not made absorption of DAK of Education of Fiscal Year 2011.
- (3) Arrangement of Report of Absorption Realization of DAK of Fiscal Year 2011 as referred to in paragraph (1) and paragraph (2) is made in accordance with Regulation of the Minister of Finance which set the implementation and responsibility of fund transfer to regions.

Article 2

(1) An example of calculation of absorption of DAK of Fiscal Year 2011 and Arrangement of Report of Absorption Realization of DAK of Fiscal Year 2011 Stage I as

referred to in Article paragraph (2) is as listed in Appendix I, as an integral part of this Regulation of the Minister of Finance.

(2) An example of calculation of absorption of DAK of Fiscal Year 2011 and Arrangement of Report of Absorption Realization of DAK of Fiscal Year 2011 Stage II as referred to in Article paragraph (2) is as listed in Appendix II, as an integral part of this Regulation of the Minister of Finance.

Article 3

Report of Absorption Realization of DAK of Fiscal Year 2011 Stage I or Stage II is submitted by the Head of Region to the Minister of Finance c.q. the Director General of Financial Balancing at least 7 (seven) business days prior to the end of the fiscal year.

Article 4

Supervision on the implementation of transmission of DAK of Fiscal Year 2011 is made in accordance with regulation of law

Article 5

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
