REGULATION OF THE MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA NUMBER 166/PMK.011/2011

CONCERNING

DETERMINATION OF IMPORT DUTY TARIFFS ON THE IMPORTED GOODS WITHIN THE FRAMEWORK OF ASEAN-AUSTRALIA-NEW ZEALAND FREE TRADE AREA (AANZFTA)

BY THE GRACE OF GOD ALMIGHTY

THE MINISTER OF FINANCE,

Considering

- : a. that in order to increase the economic cooperation between the ASEAN countries, Australia, and New Zealand, Government of the Republic of Indonesia has ratified the Agreement Establishing the ASEAN-Australia-New Zealand Free Trade Area) under the Presidential Regulation Number 26 of 2011 regarding the Determination of Agreement Establishing the ASEAN-Australia-New Zealand Free Trade Area;
 - b. that based on the agreed modalities for Indonesia, has scheduled import duty tariff decrease scheme in the framework of ASEAN-Australia-New Zealand Free Trade Area (AANZFTA);
 - c. that based on the considerations as referred to in a and b above, as well as in order to implement the provision of Article 13 paragraph (2) of Act Number 10 Year 1995 concerning Customs as amended by Act Number 17 Year 2006, it is necessary to stipulate Regulation of the Minister of Finance regarding the determination of Import Duty Tariff on Imported Goods in the Framework of ASEAN-Australia-New Zealand Free Trade Area (AANZFTA);

DECIDES:

OF : REGULATION THE MINISTER OF **FINANCE DETERMINATION** OF CONCERNING **IMPORT** TARIFFS ON THE IMPORTED GOODS WITHIN THE ASEAN-AUSTRALIA-NEW FRAMEWORK OF ZEALAND FREE TRADE AREA (AANZFTA)

Article I

- (1) Stipulate the import duty tariffs on the imported goods from the ASEAN members countries, Australia, and New Zealand within the framework of ASEAN-Australia-New Zealand Free Trade Area (AANZFTA) for the year of 2011 to 201, as set in the Attachment of this Regulation of the Minister of Finance, which is an integral part of this Regulation of the Minister of Finance;
- (2) On the import duty tariff stipulation as referred to in paragraph (1). The following provisions shall apply:
 - a. The stipulation of import duty tariff as stated in column (5) of the Attachment of Regulation of the Minister of Finance shall come into force on the promulgation of this Regulation of the Minister of Finance to December 31, 2011.
 - b. The stipulation of import duty tariff as stated in column (6) of the Attachment of Regulation of the Minister of Finance shall come into force on January 1, 2012 to December 31 2012.
 - c. The stipulation of import duty tariff as stated in column (7) of the Attachment of Regulation of the Minister of Finance shall come into force on January 1, 2013 to December 31 2013.

Article 2

(1) The imposition of import duty based on the stipulation of import duty tariff as referred to in Article 1, shall be

implemented with the following provisions:

- a. Import Duty Tariff in the Framework of ASEAN-Australia-New Zealand Free Trade Area (AANZFTA) that is lower than import duty tariff applied in general, shall only be applied on imported goods equipped with Certificate of Origin (Form AANZ) signed by authorized official in the country concerned.
- b. Importers shall put reference number of Certificate of Origin (Form AANZ) as referred to in a and facilities code in the framework of ASEAN-Australia-New Zealand Free Trade Area (AANZFTA), in the imported goods notification;
- c. Original sheet of Certificate of Origin (Form AANZ) in the framework of ASEAN-Australia-New Zealand Free Trade Area (AANZFTA) as referred to in a, shall be delivered by importers on the submission of imported goods notification as referred to in b in the Customs Office in the port of entry; and
- d. In the event that applied generally is lower than import duty tariff in the framework of ASEAN-Australia-New Zealand Free Trade Area (AANZFTA) as stated in the Attachment of this Regulation of the Minister of Finance, the tariff applied is import duty tariff applied generally.
- (2) Further provision regarding technical guidelines in implementing research of Certificate of Origin (Form AANZ) to carry out the provision on Rules of Origin in the framework of ASEAN-Australia-New Zealand Free Trade Area set in the Regulation of Director General of Customs and Excise.

Article 3

The provisions in this Regulation of the Minister of Finance shall apply to the imported goods in which the notification of the imported goods has obtained registration number from the Customs Office of entry port.

Article 4

Director General of Customs and Excise is instructed to implement the provisions in this Regulation of the Minister of Finance.

Article 5

This Regulation of the Minister of Finance shall come into force 60 (sixty) days after the date of its promulgation. For public cognizance, this Regulation of the Minister of

Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
