SECOND AMENDMENT TO REGULATION OF THE MINISTER OF FINANCE NUMBER 69/PMK.04/2009 ON POSTPONEMENT OF EXCISE PAYMENT FOR THE MANUFACTURERS OR IMPORTERS OF EXCISABLE GOODS CARRYING OUT REPAYMENT BY STICKING BANDEROLE

THE MINISTER OF FINANCE,

Considering

- : a. that in order to increase control over granting of easements of excise payment postponement for the manufacturers or importers of excisable goods carrying out repayment by sticking banderole, it is necessary to improve the provisions of easements of excise payment postponement for the manufacturers or importers of excisable goods carrying out repayment by sticking banderole;
 - b. that based on the consideration as referred to in a, it is necessary to stipulate Regulation of the Minister of Finance concerning Second Amendment to Regulation of the Minister of Finance Number 69/PMK.04/2009 on Postponement of Excise Payment for Manufacturers or Importers of Excisable Goods Carrying out Repayment by Sticking Banderole;

 - 2. Presidential Decree Number 56/P Year 2010;
 - 3. Regulation of the Minister of Finance Number 69/PMK.04/2009 on Postponement of Excise Payment for Manufacturers or Importers of Excisable Goods Carrying out Repayment by Sticking Banderole as amended by Regulation of the Minister of Finance Number 96/PMK.04/2010;

OF THE : REGULATION MINISTER OF **FINANCE** CONCERNING SECOND AMENDMENT TO REGULATION OF THE MINISTER OF FINANCE NUMBER 69/PMK.04/2009 ON POSTPONEMENT OF EXCISE PAYMENT FOR THE MANUFACTURERS OR IMPORTERS OF **EXCISABLE** GOODS CARRYING OUT REPAYMENT BY STICKING BANDEROLE.

Article I

Some provisions in the Regulation of the Minister of Finance Number 69/PMK.04/2009 on Postponement of Excise Payment for Manufacturers or Importers of Excisable Goods Carrying out Repayment by Sticking Banderole as amended by Regulation of the Minister of Finance Number 96/PMK.04/2010, amended as follows:

1. Between paragraph (2) and (3) of Article 4, paragraph (2a) inserted which reads as follows:

Article 4

- (2a)At the time of guarantee granting as referred to in paragraph (2), manufacturers that obtain postponement with company guarantee as referred to in paragraph (2) point a, shall submit copy of notarial deed as a unity of company guarantee.
- 2. Provisions of Article 5 paragraph (1) point c amended, therefore Article 5 paragraph (1) reads as follows:

Article 5

- (1) To obtain postponement with company guarantee, manufacturers shall meet the following requirements:
 - a. manufacturer is a low-risk entrepreneur based on the manufacturers profile;
 - b. manufacturer is Taxable Entrepreneur;
 - c. never violating the laws and regulations in customs sector within 2 (two) current years;
 - d. does not have excise arrears that is not paid on time, lack of clearance, administrative sanctions in the form of fines, and / or interest in the field of excise, unless the objection filed;
 - e. not on an installment payment for an invoice;
 - f. having company financial report audited by public accountant by unqualified opinions for 2 (two) years; and
 - g. having good financial performance.

3. Amended Attachment IV, therefore be as stated in the Attachment of this Regulation of the Minister of Finance, which is an integral part of this Regulation of the Minister of Finance.

Article II

- 1. At the time of this Regulation of the Minister of Finance shall apply:
 - a. to the excise payment postponement granting to the manufacturers or importers of excisable goods carrying out repayment by sticking banderole that has been issued before the enactment of this Regulation of the Minister of Finance, shall remain valid until the expiry date of excise payment postponement in accordance with what has been set in the decision regarding the excise payment postponement;
 - b. to the request of excise payment postponement granting to the manufacturers or importers of excisable goods carrying out repayment by sticking banderole received by Head of Office and have not obtained a decision before the enactment of this Regulation of the Minister of Finance, the settlement of the postponement request conducted in accordance with the mechanism set out in this Regulation of the Minister of Finance.
- 2. This Regulation of the Minister of Finance shall come into force after 30 (thirty) days from the date of promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
