# REGULATION OF THE MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA NUMBER 170/PMK.07/2011

### CONCERNING

## GENERAL GUIDELINES AND DEFINITIVE PROGNOSIS ALLOCATION OF SCHOOL OPERATIONAL ASSISTANCE FOR DISTRICT AND CITY GOVERNMENTS FOR FISCAL YEAR 2011

## THE MINISTER OF FINANCE THE REPUBLIC OF INDONESIA,

## Considering

- : a. that based on Act Number 10 of 2010 concerning State Revenue and Expenditure Budget for Fiscal Year 2011 as amended by Act Number 11 of 2011, the School Operational Assistance for Fiscal Year 2011 has been allocated;
  - b. that in order to distribute the School Operational Assistance for Fiscal Year 2011 of Fourth Quarter, it is necessary to firstly stipulate a definitive prognosis allocation of School Operational Assistance for Fiscal Year 2011, as stipulated in the Regulation of the 247/PMK.07/2010 Minister of Finance Number General Guidelines and Temporary concerning Allocation of School Operational Assistance for the District and City Governments for Fiscal Year 2011;
  - c. that based on the considerations as set forth in a and b, it is necessary to stipulate Regulation of the Minister of Finance concerning General Guidelines and Definitive Prognosis Allocation of School Operational Assistance for the District and City Governments for Fiscal Year 2011;

## DECIDES:

To stipulate

: REGULATION OF THE MINISTER OF FINANCE CONCERNING GENERAL GUIDELINES AND DEFINITIVE PROGNOSIS ALLOCATION OF SCHOOL OPERATIONAL ASSISTANCE FOR DISTRICT AND CITY GOVERNMENTS FOR FISCAL YEAR 2011.

## Article 1

- 1. Definitive prognosis allocation of School Operational Assistance (BOS) for Fiscal Year 2011 shall be sixteen trillion three hundred twenty nine billion eight hundred eighty eight million two hundred eighteen thousand two hundred fifty rupiahs (Rp16,329,888,218,250).
- 2. Details of the definitive prognosis allocation of BOS for Fiscal Year 2011 for each district and city shall be determined based on data on the number of students from the Ministry of Education and Culture.
- 3. The details of the definitive prognosis allocation of BOS for Fiscal Year 2011 as referred to in paragraph (2) shall be listed in Attachment which is an integral part of this Ministerial Regulation.

## Article 2

1. BOS Distribution for Fiscal Year 2011 of Fourth Quarter shall be equal to the difference between a definitive prognosis allocation of BOS for Fiscal Year 2011 and the amount of BOS fund for Fiscal Year 2011 which has been distributed from the First Quarter to Third Quarter as regulated in Regulation of the Minister of Finance No. 247/PMK.07/2010 concerning General Guidelines and Temporary Allocation of School Operational Assistance for the District and City Governments for Fiscal Year 2011

- 2. BOS distribution for Fiscal Year 2011 of Fourth Quarter as referred to in paragraph (1) shall be implemented at least fourteen (14) working days after the Budget Implementation Entry List of definitive prognosis allocation of BOS for Fiscal Year 2011 has been stipulated.
- 3 In case of any excess after the stipulation of a definitive prognosis allocation of BOS for Fiscal Year 2011, the excess shall calculated in the distribution of BOS allocation for subsequent Fiscal Year based on the proposal of the Ministry of Education and Culture.

### Article 3

Procedures for distribution, reporting and supervision of BOS for Fiscal Year 2011 shall be implemented in accordance with the Regulation of the Minister of Finance Number 247/PMK.07/2010 concerning General Guidelines and Temporary Allocation of School Operational Assistance for the District and City Governments for Fiscal Year 2011.

## Article 4

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
