AMENDMENT TO REGULATION OF THE MINISTER OF FINANCE NUMBER 196/PMK.011/2010 CONCERNING IMPOSITION OF ANTI DUMPING IMPORT DUTY ON IMPORT OF POLYESTER STAPLE FIBER FROM INDIA, PEOPLE'S REPUBLIC OF CHINA AND TAIWAN

THE MINISTER OF FINANCE THE REPUBLIC OF INDONESIA,

Considering

- : a. that based on Regulation of the Minister of Finance Number 196/PMK.011/2010 concerning Imposition of Anti Dumping Import Duty on Import of Polyester Staple Fiber from India, People's Republic of China and Taiwan, imposition of Anti Dumping Import Duty on Import of Polyester Staple Fiber from India, People's Republic of China and Taiwan has been stipulated;
 - b. that in order to provide legal certainty for the imposition of Anti Dumping Import Duty on import of Polyester Staple Fiber from People's Republic of China, it is necessary to make change to name of exporters or producers subject to Anti Dumping Import Duty based on provision as referred to in a;
 - c. that based on considerations as referred to in a and b, it is necessary to stipulate Regulation of Minister of Finance concerning Amendment to Regulation of Minister of Finance Number 196/PMK.011/2010 concerning Imposition of Anti Dumping Import Duty on Import of Polyester Staple Fiber from India, People's Republic of China and Taiwan;

Article I

Provision in Article 2 Number 2 (d) of Regulation of the Minister of Finance Number 196/PMK.011/2010 concerning Imposition of Anti Dumping Import Duty on Import of Polyester Staple Fiber from India, People's Republic of China and Taiwan has been amended, so Article 2 shall read as follows:
