REGULATION OF THE MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA NUMBER 173/PMK.07/2011

CONCERNING

FUND UNDERPAYMENT ALLOCATION FOR THE FOREST RESOURCES IN FISCAL YEAR 2006, 2007, AND 2009 ALLOCATED IN STATE BUDGET AMENDMENT OF FISCAL YEAR 2011

THE MINISTER OF FINANCE,

Considering

: a. that in the establishment of Fund Underpayment Allocation For the Forest Resources in Fiscal Year 2006, 2007, and 2009 for the provincial, districts, and cities which has been allocated in Act Number 10 Year 2010 on The State Budget Fiscal Year 2011 as amended by Act Number 11 Year 2011, it is necessary to stipulate Regulation of the Minister of Finance concerning Fund Underpayment Allocation For the Forest Resources in Fiscal Year 2006, 2007, and 2009 allocated in the State Budget Fiscal Year 2011;

In View of

- : 1. Act Number 33 Year 2004 on Financial Balance between Central and Regional Government (State Gazette of the Republic of Indonesia Year 2004 Number 126, Supplement to State Gazette of the Republic of Indonesia Number 4438);
 - 2. Act Number 10 Year 2010 on The State Budget Fiscal Year 2011 (State Gazette of the Republic of Indonesia Year 2010 Number 126, Supplement to State Gazette of the Republic of Indonesia Number 5167) as amended by Act Number 11 Year 2011 (State Gazette of the Republic of Indonesia Year 2011 Number 81, Supplement to State Gazette of the Republic of Indonesia Number 5233);
 - 3. Government Regulation Number 55 of 2005 on Balancing Fund (State Gazette of the Republic of Indonesia Year 2005 Number 137, Supplement to State Gazette of the Republic of Indonesia Number 4575);
 - 4. Regulation of the Minister of Finance Number 126/PMK.07/2010 concerning the Implementation and Accountability of Budget Transfer to the Regions;

DECIDES:

CONCERNING FUND UNDERPAYMENT ALLOCATION FOR THE FOREST RESOURCES IN FISCAL YEAR 2006, 2007, AND 2009 ALLOCATED IN STATE BUDGET AMENDMENT OF FISCAL YEAR 2011.

Article 1

- (1) Fund Underpayment Allocation For the Forest Resources in Fiscal Year 2006, 2007, and 2009 comes from Non-tax State Budget of Forest Resources that has not been distributed to the provinces, districts, and cities in the fiscal year concerned.
- (2) Fund Underpayment Allocation For the Forest Resources in Fiscal Year 2006, 2007, and 2009 as referred to in paragraph (1) is amounting to Rp. 37.961.352.578,00 (thirty-seven billion nine hundred and sixty-one million three hundred and fifty-two thousand five hundred and seventy-eight rupiah) with the following details:
 - a. Forest Utilization Business Permit Fees amounting to Rp. 5.283.199.998,00 (five billion two hundred and eighty-three million one hundred and ninety-nine thousand nine hundred and ninety-eight rupiah);
 - b. Provision of Forest Resources amounting to Rp. 15.967.264.485,00 (fifteen billion nine hundred and sixty-seven million two hundred and sixty-four thousand four hundred and eighty-five rupiah); and
 - c. Reforestation Fund amounting to Rp. 16.710.888.095,00 (sixteen billion seven hundred and ten million eight hundred and eighty-eight thousand ninety-five rupiah).
- (3) The details of Fund Underpayment Allocation For the Forest Resources in Fiscal Year 2006, 2007, and 2009 for the provincial, districts, and cities as stated in the Attachment, which is an integral part of this Regulation of the Minister of Finance.

Article 2

- (1) The distribution of Fund Underpayment Allocation For the Forest Resources in Fiscal Year 2006, 2007, and 2009 as referred to in Article 1 paragraph (2) implemented simultaneously in Fiscal Year 2011.
- (2) Procedures of distribution of Fund Underpayment Allocation For the Forest Resources in Fiscal Year 2006, 2007, and 2009 made in accordance with the provisions of legislation.

Article 3

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.
