NUMBER 19/PMK.07/2011 ON ESTIMATE OF REVENUE SHARING FUND
ALLOCATIONS FOR FORESTRY NATURAL RESOURCES OF 2011 FISCAL
YEAR

THE MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA,

- Considering :
- a. that in order to implement the provisions of Article 27 paragraph (5) of Government Regulation Number 55 of 2005 on Balance Fund, it needs to stipulate a Regulation of the Minister of Finance concerning Determination of Estimate of Revenue sharing fund Allocations for Forestry Natural Resources of 2011 Fiscal Year;
 - b. that based on the reconciliation result of calculation of revenue realization and distribution realization of Revenue Sharing Fund Allocation for Forestry Natural Resources from January to August period for the 2011 Fiscal Year, it is necessary to make an amendment to the estimate of Revenue Sharing Fund Allocation for Forestry Natural Resources for the 2011 Fiscal Year;
 - c. that based on considerations as referred to points a and b, it is necessary to stipulate a Regulation of the Minister of Finance concerning the Amendment to the Regulation of the Minister of Finance Number 19/PMK.07/2011 on Estimate of Revenue Sharing Fund Allocation for Forestry Natural Resources for the 2011 Fiscal Year;

Article I

Several provisions in the Regulation of the Minister of Finance Number 19/PMK.07/2011 concerning Estimate of Revenue Sharing Fund Allocation for Forestry Natural Resources for the 2011 Fiscal Year are amended as follows:

1. Provisions of Article 1 are amended to read as follows:

Article 1

- (1) Revenue Sharing Fund Allocations for Forestry Natural Resources of 2011 Fiscal Year to each region is an estimate.
- (2) Revenue sharing fund Allocations for Forestry Natural Resources as referred to in paragraph (1) shall be derived from an estimate revenue of Forest Utilization License Fee, Forest Resource Provision, and Reforestation Fund.
- (3) Revenue sharing fund Allocation for Forestry Natural Resources as referred to in paragraph (1) shall be set smaller than the ceiling of the State Revenue and Expenditure Budget of 2011 Fiscal Year by considering the realized revenue of Revenue sharing Funds for Forestry Natural Resources in the last two (2) fiscal years and the reconciliation result of calculation of revenue realization and distribution realization of Revenue Sharing Fund Allocation for Forestry Natural

Resources from January to August period for
(4) the 2011 Fiscal Year.

Revenue sharing fund Allocation for Forestry Natural Resources as referred to in paragraph (1) shall be Rp1,353,935,925,829 (one trillion three hundred and fiftythree billion nine hundred and thirtyfivemillion nine hundred and twentyfive thousand eight hundred and twentynine Rupiahs), with the following details:

- a. Forest Utilization License Fee (*Iuran Izin Usaha Pemanfaatan Hutan- IIUPH*) amounting to Rp61,329,535,187 (sixty one billion three hundred and twentynine million five hundred and thirtyfive thousand one hundred and eightyseven
- b. Rupiahs);

- Forest Resource Provision (*Provisi Sumber Daya Hutan- PSDH*) amounting to Rp738,503,697,292 (seven hundred and thirty eight billion five hundred and three million six hundredninetyseven thousand
- c. two hundred and ninetytwo Rupiahs); and

Reforestation Fund (*Dana Reboisasi- DR*) amounting to Rp554,102,693,350 (five hundred fiftyfour billion one hundred two million six hundred and ninetythreethousand three hundred and fifty Rupiahs).

(5) Details of Revenue sharing fund Allocations for Forestry Natural Resources of 2011 Fiscal Year to provincial and regency / city regions shall be as stated in Appendix, which constitutes an integral part of this Regulation

2. The provisions of Article 2 are amended to read as follows:

Article 2

- (1) Based on this Regulation of the Minister of Finance, the Director General of Financial Balance on behalf of the Minister of Finance shall determine the revised Budget Implementation Checklist for 2011 Fiscal Year in accordance with the provisions of
- (2) legislation;

The revised Budget Implementation Checklist as referred to in paragraph (1) shall be submitted to the Director General of Treasury for approval as the basis for the implementation of Revenue Sharing Fund

- (3) distribution for Forestry Natural Resources of 2011 Fiscal Year;

Procedures of Revenue Sharing Fund distribution for Forestry Natural Resources of 2011 Fiscal Year shall be implemented in accordance with the provisions of legislation.

Article II

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
