ESTIMATE OF REVENUE SHARING FUND ALLOCATIONS FOR FORESTRY
NATURAL RESOURCES OF FISCAL YEAR 2011

MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA,

Considering : that in order to implement the provisions of Article 27 paragraph (5) of Government Regulation Number 55 of 2005 on Balance Fund, it needs to stipulate a Regulation of the Minister of Finance concerning Determination of Estimate of Revenue sharing fund Allocations for Forestry Natural Resources of 2011 Fiscal Year;

Noting : Decree of the Minister of Forestry No. SK.709/Menhut-II/2010 on Determination of Producing Regions and Calculation Basis of Revenue Sharing Funds for Forestry Natural Resources Sector for 2011 Fiscal Year;

DECIDES :

To stipulate : REGULATION OF THE MINISTER OF FINANCE CONCERNING ESTIMATE OF REVENUE SHARING FUND ALLOCATIONS FOR FORESTRY NATURAL RESOURCES OF 2011 FISCAL YEAR.

Article 1

1. Revenue Sharing Fund Allocations for Forestry Natural Resources of 2011 Fiscal Year to each
2. region is an estimate.
Revenue sharing fund Allocations for Forestry Natural Resources as referred to in paragraph (1) shall be derived from an estimate revenue of
3. Forest Utilization License Fee, Forest Resource Provision, and Reforestation Fund.
Revenue sharing fund Allocation for Forestry Natural Resources as referred to in paragraph (1) shall be set smaller than the ceiling of the State Revenue and Expenditure Budget of 2011 Fiscal
4. Year by considering the realized revenue of Revenue sharing Funds for Forestry Natural Resources in the last two (2) fiscal years.

Natural Resources as referred to in paragraph (1) shall be Rp1,140,126,124,900 (one trillion one hundred forty billion one hundred twenty six million one hundred and twenty-four thousand nine hundred Rupiahs), consisting of :

a. Forest Utilization License Fee (*Iuran Izin Usaha Pemanfaatan Hutan*– IIUPH) amounting to Rp34,278,300,383 (thirty four billion two hundred and seventy eight million three hundred thousand three hundred eighty three Rupiahs).

Forest Resource Provision (*Provisi Sumber Daya Hutan*– PSDH) amounting to Rp714,631,766,186 (seven hundred fourteen billion six hundred and thirty one million seven hundred and sixty six thousand one hundred and eighty six Rupiahs).

Reforestation Fund (*Dana Reboisasi*– DR) amounting to Rp391,216,058,331 (three hundred and ninety one billion two hundred and sixteen million fifty eight thousand three hundred and thirty one Rupiahs).

5. Details of Revenue sharing fund Allocations for Forestry Natural Resources of 2011 Fiscal Year to provincial and regency / city regions shall be as stated in Appendix, which constitutes an integral part of this Regulation of the Minister of Finance.

Article 2

1. Based on this Regulation of the Minister of Finance, the Director General of Financial Balance on behalf of the Minister of Finance shall determine the Budget Implementation Checklist for 2011 Fiscal Year in accordance with the provisions of legislation;
2. The Budget Implementation Checklist as referred

- to in paragraph (1) shall be submitted to the Director General of Treasury for approval as the basis for the implementation of Revenue Sharing
3. Fund distribution for Forestry Natural Resources of 2011 Fiscal Year;
Procedures of Revenue Sharing Funddistribution for Forestry Natural Resources of 2011 Fiscal Year shall be implemented in accordance with the provisions of legislation.

Article 3

This Regulation of the Minister of Finance shall come into force on the date of its promulgation. For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
