AMENDMENT TO REGULATION OF THE MINISTER OF FINANCE NUMBER 160/PMK.07/2011 CONCERNING THE IMPLEMENTATION OF SPECIAL ALLOCATION FUND DISTRIBUTION FOR 2011 FISCAL YEAR

THE MINISTER OF FINANCE OF REPUBLIC OF INDONESIA,

Considering

- : a. that based on the Regulation of the Minister of Finance Number 160/PMK.07/2011concerning the Implementation of Special Allocation Fund Distribution for 2011Fiscal Year, the distribution and absorption procedures of Special Allocation
 - b. Fundfor 2011 Fiscal Yearhave been set; that in order to further enhance the realization of the distribution and absorption of Special Allocation Fundfor 2011 Fiscal Year, it is necessary to make an amendement to the Regulation of the Minister of Finance Number 160/PMK.07/2011 concerning the
 - c. Implementation of Special Allocation FundDistribution for 2011 Fiscal Year: that based on the considerations as set forth in point a andpoint b, it is necessary to stipulate a Regulation of the Minister of Finance concerning Amendementto Regulation of the Minister of Finance Number 160/PMK.07/2011 on the Implementation Special Allocation of FundDistributionfor2011 Fiscal Year;

In view of

- 1. Regulation of the Minister of Finance Number 126/PMK.07/2010 concerning Implementation and Accountability of Budget Transfer to Regions;
- 2. Regulation of the Minister of Finance Number 160/PMK.07/2011concerning the Implementation of Special Allocation Fund Distribution 2011 Fiscal Year;



DECIDES:

To stipulate

REGULATION OF THE MINISTER OF FINANCE CONCERNINGAMENDMENT TO REGULATION OF THE MINISTER OF FINANCE NUMBER160/PMK.07/2011 CONCERNING THE IMPLEMENTATIONOF SPECIAL ALLOCATION FUNDDISTRIBUTION FOR 2011FISCAL YEAR.

Article I

The provisions of paragraph (2) Article 1 of Regulation of the Minister of Finance Number 160/PMK.07/2011 concerning the Implementation of Special Allocation Fund Distribution for 2011 Fiscal Yearareamended so that Article 1 shall be read as follows:

Article 1

- (1) Distribution of Special Allocation Fund (*Dana Alokasi Khusus* DAK)for 2011 Fiscal Year Phase II andPhase III is implemented after regions conveytheDAK Absorption Realization Reportfor 2011 Fiscal Year, the useof which has reached90% (ninety percent) of the DAK revenue for 2011 Fiscal
- (2) Yearto the previous phase.
 TheDAK Absorption Realization Reportfor 2011
 Fiscal Yearasreferred in paragraph (1) does not
- (3) account the DAK portion and absorption of Education Sector fot2011 Fiscal Year.

 Preparation of Realization Report of theDAK Absorption Realization Reportfor 2011 Fiscal Yearas referred to paragraph (1) and paragraph (2) shall be implemented in accordance with theRegulation of the Minister of Finance, which governs the implementation and accountability of transfer budget to regions.

Article II

This Regulation of the Minister of Finance shallcome into forceon the date of its promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
