REGULATION OF THE MINISTER OF FINANCE OF REPUBLIC OF INDONESIA NUMBER 222/PMK.07/2011

CONCERNING

ALLOCATION OF REVENUE SHARING FUND OF NATURAL OIL AND GAS MINING NATURAL RESOURCES FOR 2011 FISCAL YEAR

THE MINISTER OF FINANCE OF REPUBLIC OF INDONESIA,

Considering

- : a. that to implement the provisions of article 27 paragraph (5) of Government Regulation Number 55 of 2005 on Balance Fund, it is necessary to stipulate a Regulation of Minister of Finance on Estimate of Revenue Sharing Fund Allocation of Natural Oil and Gas Mining Natural Resources for 2011 Fiscal Year;
 - b. that based on the reconciliation result of calculation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources Quarter IV for 2011 Fiscal Year, it is necessary to make adjustments to allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources for 2011 Fiscal Year;
 - c. that based on the considerations as referred to in point a and point b, it is necessary to stipulate a Regulation of Minister of Finance on Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources for 2011 Fiscal Year;

REGULATION OF MINISTER OF FINANCE CONCERNING ALLOCATION OF REVENUE SHARING FUND OF NATURAL OIL AND GAS MINING NATURAL RESOURCES FOR 2011 FISCAL YEAR.

Article 1

Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources for 2011 Fiscal Year shall be based on the realized revenue of Natural Resource of Natural Oil and Gas Mining Natural Resources for 2011 Fiscal Year.

Article 2

Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources as referred to in Article 1 is Rp33,780,701,705,564.00 (thirty three trillion seven hundred eighty billion seven hundred and one million seven hundred and five thousand five hundred sixty four Rupiahs) with the following details:

- a. Allocation of Revenue Sharing Fund of Natural Oil Mining Natural Resources is Rp15,780,564,868,738.00 (fifteen trillion seven hundred eighty billion five hundred sixty four million eight hundred sixty eight thousand seven hundred thirty eight Rupiahs);
- b. Allocation of Revenue Sharing Fund of Natural Gas Mining Natural Resources is Rp11,317,038,776,417.00 (eleven trillion three hundred seventeen billion thirty eight million seven hundred seventy six thousand four hundred seventeen Rupiahs);
- c. Reserve Fund Allocation of Revenue Sharing Fund of

Natural Oil Mining Natural Resources is Rp3,127,743,501,674.00 (three trillion one hundred twenty seven billion seven hundred forty three million five hundred and one thousand six hundred seventy four Rupiahs); and

d. Reserve Fund Allocation of Revenue Sharing Fund of Natural Gas Mining Natural Resources is Rp3,555,558,735.00 (three trillion five hundred fifty five billion three hundred fifty four million five hundred fifty eight thousand seven hundred thirty five Rupiahs).

Article 3

- (1 Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources for 2011 Fiscal Year as referred to in Article 2 point a and point b shall derived from the realized distribution of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources Quarter IV in accordance with the calculated revenue of Natural Oil and Gas Mining Natural Resources of oil and gas lifting period from December 2010 to August 2011.
- (2 Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources for 2011 Fiscal Year as referred to in Article 2 point c and d point shall be calculated from the difference in number in Article 2 point a and point b on the limit of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources in the State Revenue and Expenditure Budget for 2011 Fiscal Year.
- (3 Allocation of Revenue Sharing Fund of Natural Oil Mining Natural Resources as referred to in Article 2 Point c and Reserve Fund Allocation of Revenue Sharing Fund of Natural Oil Mining Natural Resources as referred to in Article 2 point d shall include Additional Reserve Fund Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources for Aceh Province and Allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources in the context of Special Autonomy for West Papua Province.
- (4 Details on allocation of Revenue Sharing Fund of Natural Oil and Gas Mining Natural Resources for 2011 Fiscal Year as referred to in paragraph (1) and paragraph (2) are attached in Appendix, which constitutes an integral and inseparable part of this Regulation of the Minister of Finance.

Article 4

- (1 In accordance with this Regulation of the Minister of
-) Finance, the Directorate General of Financial Balance on behalf of the Minister of Finance shall stipulate a Revised Budget Implementation Checklist for 2011 Fiscal Year.
- (2 Director General of Financial Balance shall submit the
- Revised Budget Implementation Checklist as referred to in paragraph (1) to the Director of General of Treasury as a basic of transfer in accordance with the provisions of legislation.

Article 5

- (1 Distribution procedures for allocation of Revenue Sharing
-) Fund of Natural Oil and Gas Mining Natural Resources shall be conducted in accordance with the provisions of legislation.
- (2 Allocation of Revenue Sharing Fund of Natural Oil and Gas
- Mining Natural Resources placed in the Reserve Fund Account of the Minister of Finance 2011 as referred to in Article 2 point c and point d shall be distributed to provinces and regencies/cities at last at the end of February of 2012 after the Directorate General of Budget submits the Revenue of Natural Oil and Gas Mining Natural Resources per Contractor of Cooperation Contract for oil and gas lifting period from December 2010 to November 2011.
- (3 In the case of over distribution of realized Revenue Sharing
-) Fund of Natural Oil and Gas Mining Natural Resources, the excess shall be calculated in the following budget distribution.
- (4 In the case of less distribution of Revenue Sharing Fund of
- Natural Oil Mining Natural Resources, the shortage can be distributed using the remaining Allocation of Revenue Sharing Fund of Natural Oil Mining Natural Resources.
- (5 In the case of less distribution of Revenue Sharing Fund of
- Natural Gas Mining Natural Resources, the shortage can be distributed using the remaining Reserve Fund Allocation of Revenue Sharing Fund of Natural Gas Mining Natural Resources.
- (6 In the case of less distribution of Revenue Sharing Fund of
- Natural Oil and Gas Mining Natural Resources on the realization, the shortage shall be suggested as less payment allocation in State Revenue and Expenditure Budget.

Article 6

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
