REGULATION OF THE MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA NUMBER 238/PMK.05/2010

CONCERNING

PROCEDURES FOR PROVISION, DISBURSEMENT, MANAGEMENT, AND ACCOUNTABILITY OF ENDOWMENT FUND AND EDUCATION RESERVE FUND

BY THE GRACE OF GOD ALMIGHTY

THE MINISTER OF FINANCE OF REPUBLIC OF INDONESIA,

Considering

- : a. that the State Revenue and Expenditure Budget (APBN) and / or the Revised State Revenue and Expenditure Budget (APBN-P) National Education Development Fund is allocated in the form of endowment fund and education reserve fund managed by the Public Service Agency (BLU);
 - b. that in order to get the endowment fund and education reserve fund managed by BLU conducted in a transparent and accountable manner in accordance with the provisions of financial management, it is necessary to set procedures for their provision, disbursement, management and accountability;
 - c. that based on the considerations as set forth in letters a and b, it is necessary to stipulate a Regulation of the Minister of Finance on Procedures for Provision, Disbursement, Management, and Accountability of Endowment Fund and Education Reserve Fund:

DECIDES:

: REGULATION OF THE MINISTER OF FINANCE CONCERNING PROCEDURES FOR PROVISION, DISBURSEMENT, MANAGEMENT, AND ACCOUNTABILITY OF ENDOWMENT FUND AND EDUCATION RESERVE FUND.

CHAPTER I GENERAL PROVISIONS Article 1

In this Regulation of the Minister of Finance:

1. Endowment Fund is the National Education Development Fund allocated in the APBN and / or APBN-P that aims at ensuring the sustainability of educational programs for the next generation as a form of intergenerational equity.

- 2. Education Reserve Fund is the National Education Development Fund allocated in the APBN and / or APBN-P to anticipate the rehabilitation needs of educational facilities damaged by natural disasters.
- 3. BLU Project Implementation Unit of Endowment Fund and Education Reserve Fund, hereinafter referred to BLU PIU is a unit that implements Financial Management Patterns of Public Service Agency at the Ministry of Finance.

CHAPTER II

PROVISION AND DISBURSEMENT OF ENDOWMENT FUND AND EDUCATION RESERVE FUND

Article 2

- (1) Allocation of Endowment Fund and Education Reserve Fund shall be established in the APBN and / or APBN-P.
- (2) The Minister of Finance as State General Treasurer (BUN) is the Budget User of Endowment Fund and Education Reserve Fund.
- (3) The Director General of Treasury is a Proxy of Budget User (KPA) of the Endowment Fund and Education Reserve Fund.
- (4) The Director General of Treasury may appoint a Head of Echelon II Unit within the Directorate General of Treasury to implement the KPA authority as referred to in paragraph (3).

Article 3

- (1) Based on the allocation of the APBN and / or APBN-P as referred to in Article 2 paragraph (1), the Director General of Treasury proposes to the Director General to issue a Determination Letter of Budget Unit Per Work Unit (SP-SAPSK) / Determination Letter of Work Plan and Budget (SP-RKA).
- (2) SP-SAPSK/SP-RKA as referred to in paragraph (1) shall be submitted by the Director General of Budget to the Director General of Treasury as the basis for issuance and endorsement of DIPA.

Article 4

(1) Endorsed DIPA as referred to in Article 3 paragraph (2) shall be the basis for disbursement of the Endowment Fund and Education Reserve Fund.

- (2) Disbursement of DIPA fund as referred to in paragraph (1) shall be made simultaneously into the BLU PIU account.
- (3) In the context of the disbursement as referred to in paragraph (2), Head of BLU PIU proposes the fund disbursement to the KPA, accompanied by:
 - a. Receipt, and
 - b. Certificate of Absolute Responsibility.
- (4) KPA proposes Direct Payment Order (SPM-LS) to the State Treasury Service Office (KPPN) enclosed with the Certificate of Absolute Responsibility.
- (5) The Certificate of Absolute Responsibility as referred to in paragraph (3) letter b and paragraph (4) shall be made in accordance with the format as set out in Appendix, which constitutes an integral and inseparable part of this Ministerial Regulation.
- (6) Based on the SPM-LS as referred to in paragraph (4), KPPN issues a Fund Disbursement Order (SP2D) in favor of the BLU PIU account.

Article 5

Disbursement of the Endowment Fund and Education Reserve Fund from the State Treasury to the BLU PIU shall be conducted with the following conditions:

- a. Disbursement of the Endowment Fund from the State General Treasury Account shall be accommodated in the Endowment Fund Account at the BLU PIU.
- b. Disbursement of the Education Reserve Fund from the State General Treasury Account shall be accommodated in the Education Reserve Fund Account at the BLU PIU.

CHAPTER III MANAGEMENT OF ENDOWMENT FUND AND EDUCATION RESERVE FUND Article 6

- (1) Endowment Fund, which is used by the BLU PIU, is the revenue of the said Endowment Fund management proceeds.
- (2) The revenue of the Endowment Fund management proceeds can be used for BLU PIU operations and finance education program sustainability.
- (3) Use of revenues for operations as referred to in paragraph (2) shall be conducted upon approval of the national education committee / council / team.

(4) The use of revenues to finance education program sustainability as referred to in paragraph (2) shall by a resolution of e national education committee / council / team.

Article 7

- (1) Education Reserve Fund, which is used by the BLU PIU, is the revenue of the said Education Reserve Fund management proceeds.
- (2) The revenue of the Education Reserve Fund management proceeds as referred to in paragraph (1) may be used for BLU PIU operational purposes and rehabilitation of educational facilities damaged by natural disasters.
- (3) Use of revenues for operations as referred to in paragraph (2) shall be conducted upon approval of the national education committee / council / team.
- (4) Use of revenues to finance rehabilitation needs of educational facilities damaged by natural disasters as referred to in paragraph (2) shall by a resolution of e national education committee / council / team.

Article 8

Funds used by the BLU PIU from:

- a. receipt and use of revenues of Endowment Fund management proceeds, and
- receipt and use of revenues of Education Reserve Fund management proceeds, shall be based on DIPA of the BLU PIU.

Article 9

Receipt of revenues earned from the management of Endowment Fund and Education Reserve Fund shall be implemented with the following conditions:

- a. Revenues earned from the Endowment Fund management shall be accommodated in the Endowment Fund Revenue Account at the BLU PIU.
- b. Revenues earned from the Education Reserve Fund management shall be accommodated in the Education Reserve Fund Revenue Account at the BLU PIU.

CHAPTER IV

REPORTING AND ACCOUNTABILITY OF ENDOWMENT FUND AND EDUCATION RESERVE FUND MANAGEMENT

Article 10

Reporting and accountability of Endowment Fund and Education Reserve Fund management shall be conducted in accordance with the provisions of legislation.

CHAPTER V

PROVISION, DISBURSEMENT, MANAGEMENT, AND ACCOUNTABILITY ENDOWMENT FUND AND EDUCATION RESERVE FUND IN TRANSITION PERIOD Article 11

In case BLU PIU has not been established, the Endowment Fund and Education Reserve Fund management shall be regulated with the following conditions:

- a. Implemented by the Government Investment Center;
- b. Assignment implementation of the Endowment Fund and Education Reserve Fund management as referred to in letter a shall be set by a Decree of the Minister of Finance.

Article 12

The procedures for provision, disbursement, management, and accountability of the Endowment Fund and Education Reserve Fund implemented by the BLU PIU as set forth in this Ministerial Regulation shall apply mutatis mutandis to the provision, disbursement, management, and accountability of the Endowment Fund and Education Reserve Fund held by the Government Investment Center.

Article 13

For the 2010 Fiscal Year, provision of the Endowment Fund and Education Reserve Fund conducted by the Government Investment Center does not require a Budget Business Plan document for the 2010 Fiscal Year.

Article 14

In case BLU PIU has been established, transfer of the Endowment Fund and Education Reserve Fund of the Government Investment Center to the BLU PIU shall be regulated by a separate Decree of the Minister of Finance.



CHAPTER VI CLOSING Article 15

This Regulation of the Minister of Finance shall come into force on the date of its promulgation.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
