AMENDMENT TO REGULATION OF THE MINISTER OF FINANCE NUMBER 33/PMK.07/2011 ON ALLOCATION OF FUNDS FOR PROVISIONAL RESULTS OF EXCISE TOBACCO PRODUCTS IN FISCAL YEAR 2011

THE MINISTER OF FINANCE,

Considering

- : a. that based on the Regulation of the Minister of Finance No. 33/PMK.07/2011 concerning the temporary allocation of DBH (Revenue Sharing) Tobacco Excise Fiscal Year 2011, the allocations while DBH tobacco excise Fiscal Year 2011 are based on data allocation DBH tobacco excise as determined Governor Regulation tobacco-producing and / or tobacco producing provinces;
 - b. that through regulation of the Governor of North Sumatra Province, the Governor of Riau, Jambi Province Governor, the Governor of Lampung, Jakarta Governor, the Governor of North Sulawesi, Central Sulawesi Province Governor, and the Governor of Bali Province set DBH allocations for Tobacco Excise provincial and district / municipal area concerned;
 - c. that based on the considerations set forth in paragraphs a and b, it is necessary to stipulate Regulation of the Minister of Finance on the Amendment to the Minister of Finance No. 33/PMK.07/2011 on the allocation While DBH Tobacco Excise Fiscal Year 2011;

: REGULATION OF MINISTER OF FINANCE CONCERNING AMENDMENT TO REGULATION OF THE MINISTER OF FINANCE NUMBER 33/PMK.07/2011 ON ALLOCATION OF FUNDS FOR PROVISIONAL RESULTS OF EXCISE TOBACCO PRODUCTS IN FISCAL YEAR 2011.

Article I

Several provisions in the Regulation of the Minister of Finance No. 33/PMK.07/2011 concerning the temporary allocation of DBH Tobacco Excise Fiscal Year 2011, is amended as follows:

1 The provisions of Article 2 paragraph (5) be amended so that the whole of Article 2 reads as follows:

Article 2

- (1) DBH CHT for Fiscal Year 2011 allocation of Rp1.201.357.960.000, 00 (one trillion two hundred and one billion three hundred and fifty-seven million nine hundred sixty thousand Rupiahs).
- (2) DBH CHT for Fiscal Year 2011 as referred to in paragraph (1) is 2% (two percent) of the Tobacco Excise revenue as stipulated in Act Number 10 Year 2010 concerning State Revenues and Expenditures for Fiscal Year 2011.
- (3) DBH CHT as referred to in paragraph (1) is a temporary allocation for provincial, district, and city distribution in each region is set by governors in the regions concerned.
- (4) Temporary Allocation of DBH CHT as referred to in paragraph (3), dealt with the composition of 30% (thirty percent) for the province, 40% (forty percent) for district / city regions, and 30% (thirty percent) for districts / cities.
- (5) Division Temporary DBH CHT allocation of referred to in paragraph (4) for Fiscal Year 2011 each province, district, and city of Rp1.201.357.959.903, 00 (one

trillion two hundred and one billion three hundred fifty seven million nine hundred fifty nine thousand nine hundred and three rupiahs) as contained in Annex an integral part of this regulation of minister of finance.

2 The provisions of Article 3 deleted.

Article II

The Regulation of the Minister of Finance come into force on the date of promulgation.

For public cognizance, ordered the enactment of this regulation shall be promulgated in the State Gazette of the Republic of Indonesia.
