### THE AMENDMENT TO REGULATION OF THE MINISTER OF FINANCE NUMBER 132/PMK.02/2010 CONCERNING INDEX IN ORDER IN SETTING CALCULATION OF NON-TAX REVENUES SERVICE RATES ON NATIONAL LAND AGENCY

### BY THE GRACE OF GOD ALMIGHTY

### MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA,

- Considering : a. That in order to calculate rates of service Non-Tax Revenues at the National Land Agency as defined in Government Regulation Number 13 of 2010 concerning Types and Tariffs on non-tax state revenue Applicable At the National Land Agency, has established the Ministry of Finance Number 132/PMK.02/2010 on Index Calculation in the Context Services Tariff of Non-Tax Revenues At the National Land Agency;
  - b. That by the increasing operational costs especially for the cost of measurement and mapping of land boundaries, necessary adjustment to the Special Cost Measurement Unit (Unit Cost Price Special measures) as stipulated in the Regulation of the Minister of Finance Number 132/PMK.02/2010;
  - c. Based on the considerations as referred to in letter a, and b, it is necessary to stipulate Regulation of the Minister of Finance on the amendment to the Minister of Finance Number 132/PMK.02/2010 on Index Calculation in the Context Services Tariff Non-Tax Revenues the National Land Agency;
- In View Of : 1. The Government Regulation Number 13 Year 2010 concerning Types and Tariffs on Non-Tax Revenues Applicable At the National Land Agency (State Gazette of the Republic of Indonesia Year 2010 Number 18, Supplement to State Gazette of the Republic of Indonesia Number 5100);
