REGULATION OF THE MINISTER OF FINANCE OF THE REPUBLIC OF  
INDONESIA NUMBER 58/PMK.011/2012

CONCERNING

THE IMPOSITION OF ANTI-DUMPING DUTY ON IMPORTED PRODUCTS  
CERAMIC IN THE FORM OF THE DINING AND KITCHEN EQUIPMENT, OTHER  
HOUSEHOLD EQUIPMENT AND TOILET EQUIPMENT, OF PEOPLE'S  
REPUBLIC OF CHINA

BY THE GRACE OF GOD ALMIGHTY

MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA,

- Considering :
- a. That under the provisions of Article 2 paragraph (1) of Government Regulation Number 34 Year 2011 concerning anti-dumping measures, Measures Benefits and Precautions of Trade, the import of goods subject to import duty in addition to anti-dumping duties imposed, if the export price of imported goods is lower than normal and causes the loss of the domestic industry that produces similar goods;
  - b. The corresponding results of the investigation of Indonesian Anti-Dumping Committee (KADI) there is evidence of imports of ceramic products such as tableware, kitchen tools, home appliances, and equipment toilet, dumping of the People's Republic of China that causes harm (injury) to the domestic industry and causal relationship (causal link) between the dumping of goods by the losses experienced the domestic industry;
  - c. That based on the results of the investigation Indonesian Anti-Dumping Committee (KADI) as mentioned in paragraph b, the Minister of Trade, through the letter Number 127.1/M- DAG/SD/1/2012 dated January 25, 2012 and Number 404M/DAG/SD/3/2012 dated March 9, 2012, submitted to the Minister of Finance proposed to impose anti-dumping duty on imports of ceramic products from the People's Republic of China along with the amount of anti-dumping duty rates and the duration of the imposition of anti-dumping duty is;
  - d. Based on the considerations referred to in letter a,b, and c, and in order to implement the provisions of Article 23D paragraph (2) of Act Number 10 of 1995 concerning Customs as amended by Act Number 17 of 2006, it is necessary to stipulate Regulation of the Minister of Finance on the imposition of Anti-Dumping Duty Against Imports Ceramic Products Form Eating Device, Kitchen Tools, Other Household and Toilet Equipment of People's Republic of China;

- In View of : 1. Act Number 7 Year 1994 concerning Ratification of Agreement Establishing the World Trade Organization (State Gazette of the Republic of Indonesia Year 1994 Number 57, Supplement to State Gazette of the Republic of Indonesia Number 3564);
2. Act Number 10 Year 1995 concerning Customs (State Gazette of the Republic of Indonesia Year 1995 Number 75, Supplement to State Gazette of the Republic of Indonesia Number 3612) as amended by Act Number 17 Year 2006 (State Gazette of the Republic of Indonesia Year 2006 Number 93, Supplement to State Gazette of the Republic of Indonesia Number 4661);
3. The Government Regulation Number 34 Year 2011 concerning anti-dumping measures, Measures Benefits and Precautions Trade (State Gazette of the Republic of Indonesia Year 2011 Number 66, Supplement to State Gazette of the Republic of Indonesia Number 5225);
4. The Presidential Decree Number 56 / P Year 2010:

- Noticed : 1. Letter of the Minister of Trade Number 404/M-DAG/SD/3/2012 dated March 9, 2012 regarding to the Proposed Imposition Determination of Anti-Dumping Duty Against Imports Ceramic Products from the People's Republic of China;
2. The Letter of the Minister of Trade Number 127.1/M-DAG/SD/1/2012 dated January 25, 2012 regarding to the Proposed Imposition of Anti-Dumping Duty Against Imports Ceramic Products from the People's Republic of China;
3. The Final Report of the Indonesian Anti-Dumping Committee concerning Anti-Dumping Investigation on Imported The Eating of Ceramics (Ceramic Tableware) Post Rates Heading Number. 6911.10.00.00, 6911.90.00.00, and 6912.00.00.00 which come from People's Republic of China;

DECIDES:

- To stipulate : REGULATION OF THE MINISTER OF FINANCE CONCERNING TO THE IMPOSITION OF DUTY ANTI-DUMPING ON IMPORTED THE CERAMIC PRODUCTS IN THE FORM OF TABLEWARE, THE KITCHEN EQUIPMENT, OTHER HOUSEHOLD, AND TOILET EQUIPMENT OF THE PEOPLE'S REPUBLIC OF CHINA.

Article 1

Against imports of ceramic products from the People's Republic of China in the form of:

- a. The tableware and kitchen equipments of porcelain or

china clay is included in the post rates heading 6911.10.00.00;

- b. other household and toilet equipments of porcelain or china clay is included in the post rates heading 6911.90.00.00, and
- c. The Tableware, kitchen tools, home appliances and other ceramic toilet equipment, other than of porcelain or china clay is included in the post rates heading 6912.00.00.00, Anti-Dumping Duty imposed by 87% (eighty-seven percent).

Article 2

- (1) Imposition of Anti-Dumping Duty as referred to in Article 1 is an additional duty collected from duty tariff scheme based on the preferences for exporters and / or producers in companies that come from countries that have trade cooperation with Indonesia.
- (2) In case of duty tariff scheme preferences as referred to in paragraph (1) is not fulfilled, Anti-Dumping Duty as referred to in Article 1 is an additional import duty levied by the General Duty / Most Favored Nation (MFN).

Article 3

Anti-Dumping Duty Tariff as referred to in Article 1 conducted solely to imported goods which it's the document import customs of notification has got the registration number of the customs office where the port of importation from the date of entry into force of this Regulation of the Minister.

Article 4

1. This Regulation of the Minister shall be valid for 5 (five) years from the effective date of this Regulation of the Minister.
2. This Regulation of the Minister comes into force on the date of promulgation.

So that everyone knows, it is ordered that this Regulation of the Minister be promulgated in the State Gazette of the Republic of Indonesia.
