# REGULATION OF THE MINISTER OF FINANCE NUMBER 55/PMK.011/2011

#### **CONCERNING**

# THE IMPOSITION OF SAFEGUARD MEASURE IMPORT DUTY ON THE IMPORT OF STEEL WIRE ROPES WITH TARIFF HEADING

EX 7312.10.10.00

# BY THE GRACE OF GOD ALMIGHTY THE MINISTER OF FINANCE.

Considering

- : a. that based on the results of investigation by Indonesia Trade Safeguard Committee, it has been evidenced that there was a big volume of imports of steel wire ropes with tariff heading 7312.10.10.00, which resulted in serious losses to the domestic industries:
  - b. that in the effort of following-up the results of investigation as referred to in item a, the Minister of Trade through a Letter Number: 774/M-DAG/SD/6/2010 dated June 14, 2010, Number: 1632/M-DAG/SD/10/2010 dated October 22, 2010, and Number: 1854/M-DAG/SD/12/2010 dated December 20, 2010, delivered a proposal on the imposition of Safeguard Measure Import Duty on the import of steel wire ropes with tariff heading ex 7312.10.10.00;
  - c. that based on the provisions in Article 21 of Presidential Decree Number 84 Year 2002 on Safeguard Measures to Domestic Industries from the Impact of Import Surges, a safeguard measures shall remain definable in a form of Import Duty by the Minister of Finance;
  - d. that having regards to letter a, letter b, and letter c, and in the effort of implementing the provision in Article 23D item (2) of Act Number 10 Year 1995 on Customs Clearance as amended by Act Number 17 Year 2006, it is necessary to stipulate a Regulation of the Minister of Finance on the Imposition of Safeguard Measure Import Duty on the Import of Steel Wire Ropes with Tariff Heading ex 7312.10.10.00;

#### Article 3

The Safeguard Measure Import Duty as referred to in Article 1 shall be imposed on the importation from all countries, except on steel wire ropes manufactured from those countries as listed in Appendix of this Regulation of the Minister of Finance, which constitutes an integral part of this Regulation of the Minister of Finance,

#### Article 4

- (1) The imposition of Safeguard Import Duty as referred to in Article 1 shall be:
  - a. additional general import duty (Most Favored Nation); or
  - b. additional preference import duty based on schemes of international goods trading agreement applicable in the case that the import is carried out from those countries included in said schemes of international goods trading agreement and complies with the provisions thereof.
- (2) In the case that the provisions in schemes of international goods trading agreement are not complied with, the imposition of Safeguard Measure Import Duty on the importation from the countries included in the schems of international goods trading agreement as referred to in item (1) letter b shall be additional general import duty (Most Favored Nation).

#### Article 5

On the import of steel wire ropes originating from those countries excluded from the Imposition of Safeguard Measure Import Duty as referred to in Article 3 and originating from those countries having a trading agreement with Indonesia as referred to in Article 4 item (1) letter b, the importer shall be obliged to submit Certificate of Origin.

#### Article 6

The provisions concerning tariff for imposition of Safeguard Measure Import Duty as referred to in Article 2 shall be in full effect upon the import of goods the said import customs notification document of which has obtained a registration number from the Customs Office overseeing the port of entry from the date of enactment of this Regulation of the Minister of Finance.

Article 7



- 1. This Regulation of the Minister of Finance shall come into force on the date of promulgation.
- 2. This Regulation of the Minister of Finance shall come into force for three (3) years from the date of the enactment of this Regulation of the Minister of Finance.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
