REGULATION OF THE MINISTER OF FINANCE NUMBER 58/PMK.011/2011

CONCERNING

THE IMPOSITION OF SAFEGUARD MEASURE IMPORT DUTY ON THE IMPORT OF WOVEN FABRICS OF COTTON, BLEACHED AND UNBLEACHED

BY THE GRACE OF GOD ALMIGHTY THE MINISTER OF FINANCE.

Considering

- : a. that based on the results of investigation conducted by the Indonesian Trade Safeguard Committee, it is evidenced that there was an import surge on woven fabrics of cotton, bleached and unbleached, which resulted in serious losses (injuries)to domestic industries:
- b. that in the effort of following up the results of investigation as referred to in letter a, the Minister of Trade, through Letter Number: 1852/M-DAG/SD/12/2010 dated December 20, 2010, delivered a proposal on the imposition of Safeguard Measure Import Duty on the import of woven fabrics of cotton, bleached and unbleached;
- c that based on the provisions in Article 21 of Presidential Decree Number 84 Year 2002 on Safeguard Measures of Domestic Industries from the Impact of Import Surge, safeguard measures shall remain definable in the form of Import Duty by the Minister of Finance;
- d that based on the consideration as referred to in letter a, letter b, and letter c, and in the effort of implementing the provision in Article 23D item (2) of Act Number 10 Year 1995 on Customs Clearance as amended by Act Number 17 Year 2006, it is necessary to stipulate a Regulation of the Minister of Finance on the Imposition of Safeguard Measure Import Duty on the Import of woven fabrics of cotton, bleached and unbleached;

DECIDES

To stipulate

: REGULATION OF THE MINISTER OF FINANCE ON THE IMPOSITION OF SAFEGUARD MEASURE IMPORT DUTY ON THE IMPORT OF WOVEN FABRICS OF COTTON, BLEACHED AND UNBLEACHED.

Article 1

- (1) The import of woven fabrics of cotton, bleached and unbleached shall be subject to Safeguard Measure Import Duty.
- (2) The import of products in the form of woven fabrics of cotton, bleached and unbleached, as referred to paragraph (1) shall consist of:
 - a. plain woven fabrics of cotton, containing by weight 85% or



more of cotton, unbleached, weighing not more than 100 g/m² with tariff heading 5208.11.00.00;

- b. plain woven fabrics of cotton, containing by weight 85% or more of cotton, unbleached, weighing more than 100 g/m² but not more than 200 g/m² with tariff heading 5208.12.00.00;
- c. plain woven fabrics of cotton, containing by weight 85% or more of cotton, unbleached, weighing not more than 200 g/m², in the form of 3-yarn or 4-yarn twill, including cross twill with tariff heading 5208.13.00.00;
- d. plain woven fabrics of cotton, containing by weight 85% or more of cotton, unbleached, weighing not more than 200 g/m², non 3-yarn or 4-yarn twill, and cross twill with tariff heading 5208.19.00.00;
- e. plain woven fabrics of cotton, containing by weight 85% or more of cotton, bleached, weighing not more than 200 g/m², in the form of 3-yarn or 4-yarn twill, including cross twill with tariff heading 5208.23.00.00;
- f. plain woven fabrics of cotton, containing by weight 85% or more of cotton, bleached, weighing not more than 200 g/m², neither plain woven nor 3-yarn or 4-yarn twill, and cross twill with tariff heading 5208.29.00.00;
- g. plain woven fabrics of cotton, containing by weight 85% or more of cotton, bleached, weighing more than 200 g/m², neither plain woven nor 3-yarn or 4-yarn twill, and cross twill with tariff heading 5209.29.00.00;
- h. plain woven fabrics of cotton, containing by weight less than 85% of cotton, mixed particularly or merely with synthetic fibers, weighing not more than 200 g/m², unbleached, with tariff heading 5210.11.00.00;
- plain woven fabrics of cotton, containing by weight less than 85% of cotton, mixed particularly or merely with synthetic fibers, weighing more than 200 g/m², unbleached, with tariff heading 5211.11.00.00;
- j. plain woven fabrics of cotton, containing by weight less than 85% of cotton, mixed particularly or merely with synthetic fibers, weighing more than 200 g/m², unbleached, in the form of 3-yarn or 4-yarn twill, including cross twill with tariff heading 5211.12.00.00; and



k. other woven fabrics of cotton, not from heading 5208, 5209, 5210, and 5211, weighing not more than 200 g/m2, unbleached, with tariff heading 5212.11.00.00.

Article 2

The Safeguard Measure Import Duty as referred to in Article 1 shall be imposed for three (3) years with the following conditions:

Article 3

The Safeguard Import Duty as referred to Article 1 shall be imposed on the importation from all countries, except on woven fabrics of cotton, bleached and unbleached manufactured by the countries listed in Appendix of this Regulation of the Minister of Finance, which constitutes an integral part of this Regulation of the Minister of Finance.

Article 4

- (1) The Imposition of Safeguard Measure Import Duty as referred to in Article 1 shall be:
 - a. additional general import duty (Most Favored Nation); or
 - b. additional preference import duty based on the schemes of applicable international goods trading agreement in the case that the import is carried out from the countries included in the schemes of international goods trading agreement and complies with the provisions in the schemes of international goods trading agreement.
- (2) In the case that the provisions in the schemes of international



goods trading agreement are not complied with, the imposition of Safeguard Measure Import Duty on the importation from the countries included in the schemes of international goods trading agreement as referred to in item (1) letter b shall be additional general import duty (Most Favored Nation).

Article 5

On the import of woven fabrics of cotton, bleached and unbleached originating from the countries excluded from the imposition of Safeguard Measure Import Duty as referred to in Article 3 and originating from the countries have trading agreement with Indonesia as referred to in Article 4 item (1) letter b, the importer shall be obliged to submit Certificate of Origin.

Article 6

The provisions on the imposition of the tariff of Safeguard Measure Import Duty as referred to in Article 2 shall be fully applicable on the import of goods the intended import customs notification document of which has obtained registration number from the Customs Office overseeing port of entry from the date of enactment of this Regulation of the Minister of Finance.

Article 7

- 1. This Regulation of the Minister of Finance shall come into force on the date of promulgation.
- This Regulation of the Minister of Finance shall be valid for three
 years from the date of enactment of this Regulation of the Minister of Finance.

For public cognizance, this Regulation of the Minister of Finance shall be promulgated by placing it in State Gazette of the Republic of Indonesia.
